- Programs, procedures, or equipment added to improve the company’s safety program.
- Something unique the company does or provides to promote safety.
- Individual’s contributions to the company safety program, AGC Houston, and the Houston community.
- Individual’s unique qualities or capabilities.
- Self-improvement through education, training, etc., to serve others better.
- Education of others to help them perform more safely.
- Commitment to improve safety performance.
- “Gone the extra step” to help eliminate construction accidents.
